Supreme Court turns down KY clerk second time over same-sex marriage

The U.S. Supreme Court today (November 10) rejected an appeal from a Kentucky clerk who was fined \$100,000 for refusing to issue a marriage license to a gay couple.

The Court made no statement to explain why it was not taking the case, and no justice proffered a dissent. It takes at least four justices to agree to hear a petition before the full bench take up the matter.

The petition by Rowan County clerk Kim Davis, 60, was a long shot, and Davis had tried before to petition the Supreme Court to reverse a lower court

decision.

The thrust of this petition was to seek a declaration from the Supreme Court that the county—not Davis—should be required to pay the \$100,000 levied against Davis for refusing to issue the marriage license to David Erno and David Moore.

In addition to the fine, Davis was jailed briefly for several days for refusing to issue marriage licenses to same-sex couples. She also accrued \$250,000 in attorneys' fees. The primary issue of her petition to the Supreme Court was her argument that, as county clerk, she had qualified

LGBTQ+ representation on primetime TV grows thanks to shows like 'Abbott Elementary' and 'Hacks'

NEW YORK (AP) — TV shows like "Abbott Elementary," "Hacks," "Heartstopper," "The Last of Us" and "Yellowjackets" helped increase the ranks of LGBTQ+ characters on prime time by 4% over the previous season, according to a new study by the advocacy group GLAAD.

This year's "Where We Are on TV" study, released Thursday, counted 489 LGBTQ+ characters across scripted prime-time broadcast, cable and streaming shows — up 21 additional

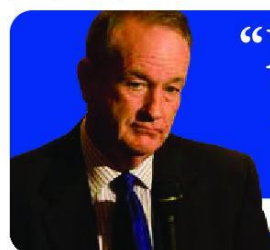

Building on victory

The bloom is off Trump's stink-blossom

Voters handed Democrats a sweeping victory across the country in the November 4 elections. Donald Trump's Republicans paid dearly for their inability to restrain or conceal their recklessness and cruelty.

In response to being roundly repudiated at the polls, Trump boasted, lied, made insults and threats. Mind you, this is a man who confuses dementia screening with an IQ test. And he once proposed nuking hurricanes.

Trump's howlers, including the claim that every election he loses is rigged, are persuading fewer and fewer people.

You would never know, on this bright autumn morning, that a pitched battle is underway for the soul of America. As I sip my coffee in the McDonald's, a little girl walking by with her daddy climbs into the chair at the next table. She is holding a TV remote control for some reason. I ask her not to point it at me because I don't want to be switched off.

To be honest, there are people I wouldn't mind switching off, at least from my newsfeed. For example, I saw this headline concerning an obnoxious congresswoman: "Nancy Mace escalates fallout from foul-mouthed airport meltdown with legal threats after criticism from fellow Republicans."

Is it possible that Rep. Mace, who is running for governor of South Carolina and has been calling trans people crazy, is so starved of attention that she has to scream at officers in airports and threaten lawsuits? I stress that I'm just a humble commentator and do not mean to provoke her.

I can't help recalling that the phrase "Trump Derangement Syndrome" arose not as a reference to Trump's own mental health issues but as an effort to deflect such concerns onto his critics. Lately, however, we who wish to be rid of the Worst President Ever have gone from being mad to being domestic terrorists in the eyes of Trump diehards. We are also called insurrectionists, despite never having incited a riot at the US Capitol, because the leading insurrectionist—who deems himself above the law—is considering invoking the Insurrection Act to consolidate dictatorial power.

Are you keeping up with all this? I know it sounds crazy. You never know what jarring images you'll stumble upon. On election night I switched to CNN, saw former Chicago mayor Rahm Emanuel, and immediately reached for my remote control like that little girl in the McDonald's. And Rahm is a Democrat!

New York City Mayor-elect Zohran Mamdani is an immigrant who grew up in New York. I am a native Washingtonian who grew up in Maryland's 8th congressional district, currently represented by constitutional scholar Jamie Raskin. Raskin has happily dubbed Mamdani an FDR Democrat.

You might think comparing a gifted young politician to Franklin Delano Roosevelt would not scandalize anyone at this point; but you would be wrong. Lots of Republicans still decry FDR as a socialist. These are the same people set on robbing millions of their healthcare and nutritional assistance.

Trump, who hosted a Great Gatsby-themed party at Mar-a-Lago hours before millions of Americans lost their SNAP benefits, touted the Roaring Twenties as a high point in America's past. I don't want to burst his bubble, so please don't tell him that the 1920s ended in a stock market crash that ushered in the Great Depression. God forbid his tariffs lead to another crash. He would likely blame it on Mamdani, rebrand it a communist Islamic jihad, and deport it to Eswatini.

Democrats like me support capitalism, but with guardrails. By contrast, the oligarchs—epitomized by Elon Musk with his recently approved \$1 trillion pay package—love to blame others for the harm they cause, while making off with the moolah. Do not fall for it.

I am rooting for Mamdani, who wants working people to be able to afford to live in New York. He includes trans people in his vision. His victory speech was a far cry from the Islamophobic caricature painted by his detractors, who range from right-wing pundits to Andrew Cuomo.

Based on the smears, you might expect the mayor-elect to rush to Washington to demolish part of the White House, had the president not beaten him to it. Yet in the wake of Mamdani's historic victory, billionaires who fought tooth and nail to defeat him bent the knee and pledged their help.

Mamdani is not the model for all Democrats; he reflects but one part of our diverse coalition. The midterm elections are a year away. All our voices and votes will be needed to defeat the authoritarians.

Two Major Queer Arts Festivals Open Submissions for 2026

Fresh Fruit Festival and Newark LGBTQ Film Festival Seek LGBTQ+ Works

Two prominent East Coast LGBTQ+ arts festivals are now accepting submissions for their 2026 seasons, offering queer creators multiple platforms to showcase their work this spring.

The Fresh Fruit Festival, entering its 24th year as New York City's premiere year-round LGBTQ+ theatre festival, has opened submissions for its MainStage programming, scheduled to run April 20–May 3, 2026, at The Wild Project. The festival seeks full-length plays, one-act plays, and musical events that are LGBTQ+-themed or include elements of interest to the community.

"The Fresh Fruit Festival is a vital platform for queer voices, and we are thrilled to bring the MainStage back to The Wild Project," said an All Out Arts spokesperson. "We invite playwrights, composers, and performers to join us in making the 24th year one of our most vibrant and inclusive festivals yet."

The festival is offering an Early Bird submission window through December 8, with scripts

read first and early acceptances receiving more time for casting and promotion. Regular submissions run mid-December through mid-January, with notifications at the end of January. Complete guidelines are available at freshfruitfestival.com/mainstage26-app.

Meanwhile, the Newark LGBTQ Film Festival has launched submissions for its fourth annual event, taking place April 30–May 4, 2026. The festival, which saw audience participation double in its most recent edition, focuses on elevating Queer BIPOC films and filmmakers.

"We are excited to continue elevating the work of BIPOC Queer filmmakers, actors, and creatives from across our city, state, and country—right here in Newark," said Festival Director Denise Hinds.

The Newark festival accepts short films, documentaries, experimental works, student projects, and select feature-length films via FilmFreeway. Deadlines are: Early Bird (December 18, 2025), Regular (January 21, 2026), and Late (February 11, 2026). Filmmakers will be notified by March 7, 2026.

by seeing people step up to do the right thing.

I am also buoyed by recent election wins that indicate many are eager for a government that helps and uplifts people, rather than harms and belittles them. We saw recent progress, too, as the Illinois General Assembly on October 29 passed the Equality for Every Family Act, which updates the state's parentage laws to better protect the children of LGBTQ+ parents and others formed via assisted reproduction, following 13 other states with similar comprehensive and inclusive parentage legislation. These wins should not blind us to ongoing anti-trans rulings, attempts to roll back marriage equality, and other anti-LGBTQ+ actions that we must continue to challenge. But they offer a spark of hope that all is not lost.

That leads me to my gratitude for being part of the queer community, which remains vibrant and strong despite everything that has been thrown at us. We have a history of resilience and resistance that will carry us forward.

As a queer parent, furthermore, I find tremendous hope for the world as I see many queer people still wanting to start and expand

their families. In fact, resources for queer family building continue to flourish, from newer organizations like GWK Academy and Pregnant-Together, long-established ones like Family Equality, and from local LGBTQ+ parenting groups, fertility clinics, and adoption agencies, among others.

I take heart as well from the ongoing representation of queer people and families in children's books and media. Representation in books has particularly grown over the past decade, with both the number of titles and the range of representation (queer and intersectional) increasing. Attempts to ban these books in many schools and libraries are still on the rise—but based on the number of titles I have queued up to review next year (and into 2027), authors and publishers aren't slowing down. There is a demand for these books because they give children important images of themselves, their families, and their world. Representation in on-screen media remains more limited, especially for younger children, as GLAAD's recent "Where We Are on TV 2024-2025" report shows, but is a definite improvement from where things were a decade ago.

Finally, I am grateful for the queer parents who have gone before, starting and raising children with much less support and fewer re-

sources than we have today. Their experiences and the paths they charted still inform and inspire. Lately, for example, I have been thinking about a quote from Joy A. Schulenburg's 1985 book "Gay Parenting," one of the first published books on the topic. She wrote, "Throughout history, gay men and lesbians have been innovators, creative spirits and heralds of social change. As we seek to expand our horizons and invest our nurturing energy in another generation of human beings, let's hope that we can pass on to them our best selves—generous, talented, and possessing a tremendous capacity for love." I'd now widen the sentiment to include the full LGBTQ+ spectrum, but otherwise think it remains a valuable message for today.

The winter holidays mark a time of rebirth, of knowing there will be light after the darkness. That seems appropriate for the LGBTQ+ community right now. As we begin the season, then, let us use this time to reflect and recharge, to give thanks for our families and our communities, however we define them, and to find ways we can continue to make a difference.

After a friend informed me a few weeks ago that Burns' documentary portrayed Revolutionary War General Baron Friedrich Wilhelm von Steuben in a disingenuous and harmful way, I promptly reached out to both Terry Gross of NPR and the Museum of the American Revolution, who both had scheduled events with Burns, and soon after got a call from Burns' team, led by Burns co-directors Sarah Botstein and David Schmidt. We met on Zoom, they shared the relevant clip with me (which was, indeed, disingenuous and harmful), and I explained why their portrayal of von Steuben was historically thin and reinforced harmful tropes.

It is often difficult for heterosexual historians to fully appreciate how LGBTQ+ people have been labeled throughout history. From my conversation with Burns' team over the last month, it seems we agreed that most credible historians now accept that Baron von Steuben would be considered a gay man by today's understanding. That is never mentioned in the documentary. They risk erasing the fact that a gay man played a significant and indispensable role in founding this nation. Yet in Burns' documentary, the only reference to his sexuality is a single line: "he took familiarities with boys." That claim is misleading, damaging, and more harmful than if he'd just kept von Steuben in the closet. It reinforces the dangerous idea that all gay people are pedophiles.

That line, which the producers believe to be "fact," is based on a single rumor from a religious order with whom von Steuben had political conflict. Historians have often repeated it not because it is well-founded, but because it conveniently fits the long history of how gay men have been smeared through innuendo. In my correspondence with Paul Lockheart, who authored the definitive von Steuben biography "The Drill-

master of Valley Forge," he told me he didn't believe those rumors to be true. Even more institutions, including the Smithsonian, have called the rumors unproven and anonymously reported.

If Burns' film fully accepts the allegation, made in 1777, at face value, the logic becomes absurd: it would require the viewer to believe Benjamin Franklin knowingly sent a pedophile to George Washington to train our troops. Franklin was many things, but he was not a fool.

His note to George Washington reads:

"Sir,

I beg leave to recommend to your Excellency the Baron de Steuben, a gentleman of rank and military experience, who served for many years with great reputation in the Prussian Army under the King of Prussia. His zeal for our cause has brought him from Europe at his own expense, with a desire to offer his services to the United States.

I make no doubt his knowledge and discipline will be of great use in forming our troops. I therefore take the liberty to recommend him to your Excellency's attention and favorable notice.

*With great respect,
B. Franklin"*

Franklin's letter — along with the writings of George Washington, Alexander Hamilton, and Thomas Jefferson — all portray von Steuben as a man of extraordinary integrity and a true hero of the Revolution. None of that balance or historical nuance appears in Burns' series.

Sadly, I've seen this kind of distortion before. More than fifteen years ago, during a televised debate on LGBTQ+ equality, an opponent leaned across the set and snarled at me: "This country was not founded for people like you." I answered that one of the men who helped found this nation was "like me," General von Steuben. By then I had already spent years researching and writing about him. One of my lines has been repeated so often

it's practically folklore: Benjamin Franklin sending von Steuben to the Continental Congress made Franklin the father of "Don't Ask, Don't Tell."

In Burns' portrayal of the Revolution, LGBTQ+ people are not only erased but defamed, reduced to a caricatured trope instead of being recognized as real participants in shaping our country's history. And this type of omission is not new in his documentary work.

In his 2014 series "The Roosevelts," he faced criticism from historians and LGBTQ+ advocates for omitting Eleanor Roosevelt's close and well-documented relationship with Lorena Hickok. In his 2017 documentary on the Vietnam War, there was no mention of Sgt. Leonard Matlovich, the most famous LGBTQ+ service member of that era and the poster figure for "Don't Ask, Don't Tell," or any other LGBTQ+ veteran who served. Taken together, these choices form a troubling pattern: showing America that LGBTQ+ people don't exist.

Burns' documentary correctly highlights von Steuben's crucial role in transforming Washington's troops and helping win the war. But it ends that portrayal with the oldest, most dangerous stereotype used against gay men. That isn't history. That isn't education. It's a blatant disservice to the truth, to viewers, and to von Steuben's legacy. That's what I take away from "The American Revolution."

LGBTQ+ Americans have always been part of our nation's story. We're done being erased, sidelined, or misrepresented. And as long as documentaries, museums, and classrooms continue to perpetuate old myths, we will keep demanding the accuracy our history deserves.

immunity for actions she took as a public official.

Tacked onto that petition was a question asking the Supreme Court to overturn its decision in *Obergefell v. Hodges*. *Obergefell* is the 2015 decision in which the court ruled 5 to 4 that states could not ban same-sex couples from obtaining marriage licenses.

Attorneys for the gay couple urged the Supreme Court to deny Davis's petition. Among other things, they noted that "Rather than attempting to invoke a religious exemption for herself, Davis instead

exercised the full authority of the Rowan County Clerk's office to enact an official policy of denying marriage licenses to same-sex couples, one every office employee had to follow."

The couple filed a lawsuit against Davis for refusing their application for a marriage license. In response to the latest petition to the Supreme Court, the couple's attorneys noted that the Sixth Circuit U.S. Court of Appeals held that in "the

absence of any legal authority to support her novel arguments," Davis "should have known that *Obergefell* required her to issue marriage licenses to same-sex couples—even if she sought and eventually received an accommodation."

Only two entities filed friend-of-the-court briefs in the petition this time around: one from a Long Beach, California, attorney who said he represented clients who said they had "suffered greatly" from having had same-sex parents. The other was from the National Organization for Marriage, which opposes allowing same-sex couples to obtain marriage licenses. NOM's brief said the Supreme Court should overturn *Obergefell* because the gay couple could have gone to another clerk to obtain the marriage license, rather than force Davis—who claimed religious beliefs against homosexuality—to issue it.

Jenny Pizer, Senior Director of Strategic Initiatives at Lambda Legal, had predicted the Court would not take the petition, noting that the Trump administration has not been intensely focused on marriage licenses.

Davis ran for re-election in 2018 but lost.

characters. It marks a boost after two years of decline, but remains far below the 2021-2022 record high of 637 characters.

Sarah Kate Ellis, president and CEO of the group, warned that those numbers could still decrease soon: More than 200 of the LGBTQ+ characters counted this year—in shows like "Heartstopper," "Harlem" and "Elite"—will not be returning due to a flurry of series cancellations, endings or because they were limited series.

"Storytelling brings us together and this current cultural and political climate calls on creatives and executives to double down on fair and accurate stories of LGBTQ+ people," Ellis writes in the report.

GLAAD added that the number of transgender characters on TV has slightly increased from last year to reach 33—24 trans women, seven trans men, and two nonbinary characters—but only four trans characters appear on series that have been officially renewed.

The report is the 20th edition of the annual tracking by GLAAD and charts a remarkable leap from just 47 LGBTQ+ characters in the first study. It arrives as President Donald Trump has targeted transgender and nonbinary people with a series of executive orders—including one declaring the existence of two unchangeable sexes—stripping government websites of "gender ideology" and re-instituting a ban on transgender service members in the military.

A recent Gallup poll found 9.3% of U.S. adults identified as lesbian, gay, bisexual, transgender or something other than straight or heterosexual. The percentage has more than doubled since Gallup first measured LGBTQ+ identification in 2012.

The GLAAD study found that representation

on broadcast and cable have continually declined, while streaming programming saw an increase of LGBTQ+ characters.

ABC last season had the largest percentage of network LGBTQ+ series regulars—with 12.9%—while Netflix had the most LGBTQ+ characters on streaming, with 177. It found that the eight major streamers added 45 characters from the 327 in the previous period.

GLAAD noted LGBTQ+ characters in such network shows as NBC's "Brilliant Minds," which has a gay lead, CBS dramas "Matlock" and "Watson," both of which feature supporting queer women, and ensemble characters on comedies like Fox's "Going Dutch" and NBC's "St. Denis Medical."

On streaming, GLAAD cited Netflix's "The Four Seasons," "Arcane" and "Kaos," and Amazon's "Clean Slate," "Harlem" and "The Wheel of Time." Hulu, meanwhile, had "Mid-Century Modern," "Big Boys" and "Wreck."

The study found that the percentage of characters of color slightly increased up to 51% of all LGBTQ+ characters counted, and, for the second year in a row, only one LGBTQ+ character was depicted as living with HIV—but that character, on HBO Max's "Cris Miró," won't be returning.

In their 2019-20 study GLAAD had asked the industry to reach 20% representation of regularly seen LGBTQ+ characters on all three platforms by 2025, and to ensure that half of LGBTQ+ characters on every TV platform were people of color within the next two years. This year's report does not include a challenge tied to a specific percentage.

"As this study and the TV industry have evolved, so too have our benchmarks," GLAAD said. "There is a need for urgent action and improvement today across all platforms with this newest study finding a significant portion of the LGBTQ characters counted will not return."

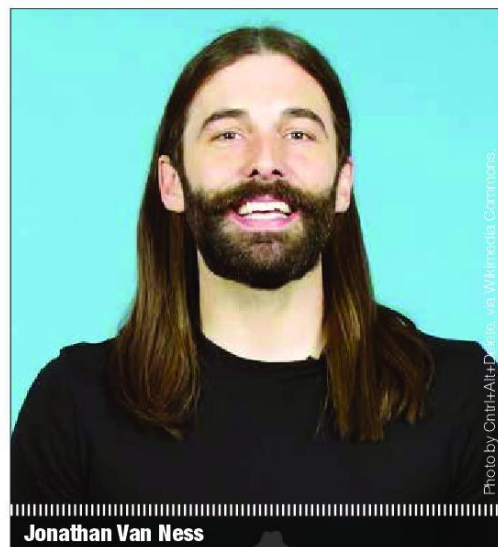

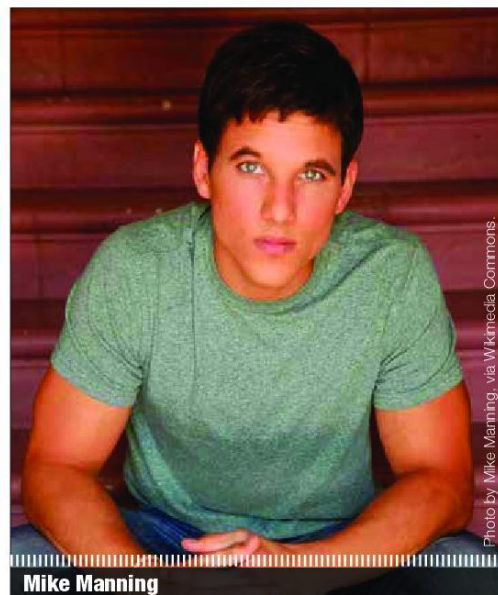

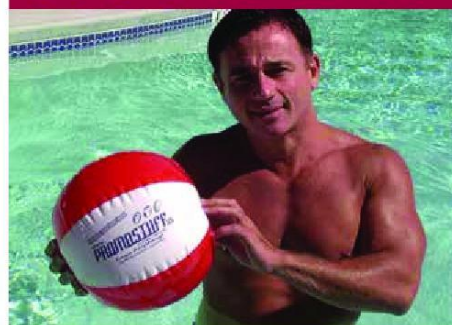
