

Pride Parade and Festival to Return to Boston

Boston LGBTQ+ Celebration Set for June; Pride Organizers Call for Volunteers and Sponsors

BOSTON — Boston Pride For The People (BP4TP) announced the return of a Pride Month celebration in Boston. The celebration will be held in June 2023, and will include a parade, a festival, block parties, and more. The parade and festival will take place on Saturday, June 10th on Boston Common and at City Hall Plaza. Other activities will

NH School reverses urinal ban after bathroom access debate

MILFORD, N.H. (AP)— A New Hampshire school board has reversed a policy banning middle and high school students from using urinals after dozens protested the measure, which had been a compromise to a proposal that would have blocked students from using facilities based on their gender identity.

Students at Milford Middle School and Milford High School can still access the bathroom that "corresponds to their gender identity consistently asserted at school."

But at its Feb. 6 meeting, the school

board debated a proposal that would require students to use the restroom and locker room of their assigned sex at birth. The proposal upset transgender students, gender nonconforming stu-

Court to reconsider CT's transgender athlete policy

HARTFORD, Conn. (AP)— A federal appeals court has reinstated a challenge to Connecticut's policy of allowing transgender girls to compete in girls high

school sports, two months after a three-judge panel upheld the rules.

The 2nd U.S. Circuit Court of Appeals in New York City said the full court will rehear the appeal of four transgender runners who said they were unfairly forced to race against transgender

athletes in high school competitions.

The court said in a decision Monday that a majority of its judges voted in favor of rehearing the appeal, a rare move by the court. The court did not say why it

IN MEMORIAM

Alice Wolf

December 24, 1933 –
January 26, 2023

In the Summer of 1987, I got on my bicycle, attached a flag to the back of it, and rode through Cambridge with comrades from the National Organization for Women: Women on Wheels for Wolf, our flags declared. Afterwards, we gathered with the candidate whose run for office we endorsed. This was when I first got to know the wonderful, indomitable Alice Wolf. Over the years, when she was City Councilor and then Mayor for the City Cambridge, and when she served as its State Representative, we worked together on issues of women's

rights, LGBTQ equality, combating racism and working for economic justice.

I had the honor of working with her when she gathered a group to draft and pass what would be landmark domestic partnership legislation. I saw her deep commitment to women's rights and to making sure that wom-

Nonbio Mom Vs. Sperm Donor Case Is a "Call to Action"

An Oklahoma judge has ruled that a married, nonbiological mom has no parental rights to the child she and her wife created and were raising together, but the couple's sperm donor does. The case shows both why LGBTQ families need to take extra steps to protect themselves, and why there is a critical need for reform of parentage law across the country.

Kris Williams and Rebekah Wilson married in 2019 and had a son later that year with the help of Harlan Vaughn, a gay man who agreed to be their sperm donor, court documents say. Wilson carried the child, and both women's names were placed on his birth certificate. The child was

given Williams' last name, and the two women jointly parented him for two years.

Wilson and Williams wanted their child to know his donor, however, as they had heard from other donor-conceived people that this was important to them. They therefore let Vaughn meet the child and spend time with him.

In December 2021, Wilson filed for divorce, claiming there were no children "of" the marriage, but that Vaughn is the father to the one child born during the marriage. At the same time, she obtained a Victim Protec-

be held in the preceding week and throughout the month. BP4TP is a new organization formed to reimagine the annual celebration that hasn't been held in person since 2019.

"It's time for a unified Pride for everyone to enjoy," said Adrianna Boulton, President of BP4TP and Director of Community Impact & Engagement at Fenway Health. "The last time we came together, there was a different President, a different Governor, a different Mayor. The pandemic kept us apart for a long time. Now, all of us are eager to reconnect, embrace each other as a community, and most importantly have fun."

"Thank you so much to the organizers who have been working to build and ground the evolution of Pride in community," said Mayor Michelle Wu. "Boston has a long history of advancing LGBTQ+ equality, and I'm so grateful to Boston Pride for the People to keep this legacy going and ensure the success of this year's events. The newly formed group worked over the past year to ensure that input on the Pride events included a broad chorus of voices. Boston Pride For The People has established a mission that aims to improve the lives of LGBTQ+ people by emphasizing activities and experiences that EMPOWER, CELEBRATE, EDUCATE, AND COMMEMORATE:

- **Empower** through creating LGBTQ+ community and respectfully reaching across differences to support and love one another
- **Celebrate** and honor the rich, diverse, creative, and fabulous culture of LGBTQ+ communities, while imparting knowledge of LGBTQ+ history and a sense of pride among LGBTQ+ youth
- **Educate** and advocate broadly about oppression that LGBTQ+ people still experience, especially LGBTQ+ people who face multiple forms of oppression

Chatbots from the edge Let's deal with current challenges, not science fiction

All the talk of UFOs flying above us and being shot down takes me back to my youth when I read science fiction novels about invasions by space aliens. Some covers would feature an alien carrying a scantily clad, busty young woman, invariably unconscious. That was before Sigourney Weaver kicked butt in the *Alien* movies.

If I were commissioning art for those books, I would base a cover on Michelangelo's *Pietà*, with a beautiful young man passed out in the alien's arms. Just because you're a bug-eyed monster out to conquer the Earth doesn't mean you can't have good taste. This, however, was the 1970s, when most sci-fi editors were nerdy straight guys with cramped imaginations.

Another development that echoes sci-fi stories is Microsoft's artificially intelligent Bing chatbot that professed its love for one reporter and described dark fantasies like hacking computers.

I'm not too worried about chatbots, though they could well replace House Republicans who haven't an ounce of wit but can recite the latest talking points. Would anyone notice if Kevin McCarthy were replaced with a robot? (I apologize to robots for that remark.)

Astrophysicist Neil deGrasse Tyson noted recently that an alien species capable of crossing the vastness of space would be far more advanced than humans and would not need to sneak around.

At present, we are unlikely to encounter alien spacecraft much less shoot them down, and are not at a point

when sentient computers will launch wars on their own, though our technology advances faster than our wisdom.

Entertaining as they are, science-fiction scenarios are a distraction from present-day threats like nihilistic demagogues manipulating gullible people. Who needs shape-shifting aliens when we have Nikki Haley? She is so all over the place in her pandering to the Republican base that she could have been one of the victims in the movie *Jaws*.

After Haley's presidential campaign launch in which she said America is not racist (which raises the question why she found it necessary to abandon her first name, Nimrata), conservative troll Ann Coulter told her, "Why don't you go back to your own country?" It is discouraging that, after such a long struggle, the right wing still does not see large swaths of America's population as Americans.

But the fact that Trump's MAGA hordes don't even bother faking moderation is their Achilles heel. They constantly go too far with their ridiculous rhetoric. For example, QAnon cultists insist that Democrats are satanic, cannibalistic pedophiles. Granted, I think freshman Congressman Maxwell Frost of Florida is brilliant and adorable, but the most I would do is join him for lunch, not have him for lunch. And he is 25, not 15. As for devil worship, they should stop projecting.

The Gen Z-ers of which Frost is the vanguard are not troubled by sexual minorities, and are not traumatized

by learning the less heroic details of America's past. These young citizens are used to mass-shooting drills. They are familiar with diversity and do not regard it as an existential threat.

Not most of them, at least. Without fixations and resentments being passed down from generation to generation, there would not still be people eager to re-fight the Civil War. But shielding children from outside influences is increasingly difficult.

The far right in its paranoia is unable to adjust to changing demographic trends and is uninterested in solutions. By contrast, the emerging generation will not be fooled by bullies who pose as freedom lovers, nor tolerate greedy industrialists who socialize risks while privatizing profits.

That's my bet. There is more of a future in cooperating to solve problems together. Still, Republicans enjoy structural advantages in our political system (e.g. the Senate and Electoral College), and have been taken over by fanatics as surely as if they were alien changelings. It's like the old movie, *Invasion of the Body Snatchers*. Don't go to sleep!

A friend warns, regarding Twitter, "You never know whether you're engaging a person or a bot." True, but sometimes a writer's work involves dancing on the edge. And simulated friends might assuage someone's isolation at a remote outpost. In the end, however, we need flesh-and-blood people in our lives, not just imitations on a screen.

If we broke out of our electronic bubbles and encountered actual human beings more often, right there in front of us, who knows? It might restore a healthy dose of reality to our politics.

tion Order against Williams, alleging domestic abuse and banning Williams from contact with Wilson or their son for five years. Regardless of the allegations there (which Williams has denied but that are not available to the public), that is a separate matter from whether Williams is a legal parent.

Vaughn also filed a motion in 2022 to establish his parental rights, and on February 13, 2023, Oklahoma County District Court Judge Lynne McGuire ruled in his favor, denying that Williams is the child's parent. The ruling explained that "The Uniform Parentage Act that Oklahoma adopted was enacted in 2006 and does not take into account same-sex marriage, and there is no presumption that the wife of the mother is automatically the presumed parent of a child born during the marriage."

Polly Crozier, director of family advocacy at LGBTQ legal organization GLAD, told me, "This case highlights the vulnerabilities LGBTQ+ families and their children still live with. Like all family law matters this story is complex, but the court's conclusions are deeply concerning on several fronts."

The case hinges on whether same-sex married couples have the right to the presumption of parentage, the legal principle long applied to heterosexual couples that any child born within a marriage is presumed to be the child of both spouses.

Crozier observed that McGuire "disregarded the marital presumption of parentage that should have applied in this situation, finding that the presumption does not apply to LGBTQ spouses. The judge's refusal to apply Oklahoma's parentage statutes to this child be-

cause the decades-old law uses gendered language runs contrary to constitutional principles."

These principles, she explained, were articulated in the U.S. Supreme Court rulings *Obergefell v. Hodges*, which established nationwide marriage equality, and *Pavan v. Smith*, which said both parents in a same-sex couple have the right to be on their children's birth certificates. "Those decisions affirmed that all married people should be treated equally and have equal access to the rights and responsibilities of marriage, including the marital presumption of parentage," she said.

Despite those rulings, LGBTQ legal advocates have long advised that because not all states may honor that marital presumption for same-sex couples, even married nonbiological/nongestational parents who are on their children's birth certificates (an ability based on the marital presumption) should also get a co-parent/second-parent adoption, court order of parentage, or the equivalent. Unlike birth certificates, these other actions legally establish (and don't just record) a relationship between the child and the parent and are guaranteed "full faith and credit" in all states.

Williams did not get a co-parent adoption, however. Because she could have pursued one but chose not to, McGuire said in the ruling, that counted against her claim.

Williams' attorney Robyn Hopkins has told the media that they will appeal the decision.

"Beyond the heartbreaking implications for this child, whose relationship with one of their parents has now been legally severed, this case should be a call to action," Crozier said. "States must ensure their parentage laws are updated and inclusive of LGBTQ families and their children, and there's a model for doing so—the Uniform Parentage Act of 2017."

Oklahoma's parentage laws, like those in 24 other

states, are based on the Uniform Parentage Act (UPA), model parentage legislation developed by the Uniform Law Commission, a non-partisan body of state lawmakers, judges, scholars, and lawyers. The UPA was first developed in 1973, then updated in 2002 to expand ways of determining legal parentage for children born through assisted reproduction, and in 2017 to ensure that state parentage laws remain constitutional by providing equality and paths to parentage for LGBTQ families, among other changes.

Seven states (California, Colorado, Connecticut, Maine, Rhode Island, Vermont, and Washington) have adopted the 2017 UPA or substantially similar legislation. Hawaii, Kansas, and Massachusetts have introduced bills this session to do so. New Hampshire and New York have also adopted some similar provisions. Oklahoma's parentage laws, however, and those of 10 other states, are still based on the 2002 UPA; other states are further behind.

Crozier stressed, "This case is also a painful reminder that LGBTQ+ families still need to make sure that they do everything they can to protect their children, including completing co-parent adoptions."

She recommended that LGBTQ parents consult the "What LGBTQ+ Families Need to Know" guide (glad.org/post/faq-protect-your-family) created by GLAD, NCLR, COLAGE and Family Equality "to help families understand what they can do now to protect their children and their families, while we continue to advocate for updated parentage laws across the country."

en's voices were heard in the political realm. I remember battles for economic fairness and her work to racial equality.

Over the years, I came to know and love the sincerity, the doggedness and the deep decency Alice brought to everything she did. Hers was never empty rhetoric left to one side when time came for the real work. Quite the contrary: She often forgot about the stuff that felt less real to her. I remember reminding her to draft a press release when the domestic partnership legislation passed. She needed to take appropriate credit for her amazing work, I told her. She shrugged; she just wanted to get the right thing done. So, in that instance and others, I made her sit on the phone with me as I drafted a press release for her. This was never her first thought. She made a difference in the world because she believed in doing that work. That was enough for her.

Alice loved the City of Cambridge, and she was clear eyed about its challenges. So, in 2008, when I needed a witness to explain City government at a trial against her beloved City for race discrimination and retaliation, the former Mayor stepped up. She was fabulous.

Alice also cared deeply about others. Some

public officials do well in public space and perhaps not so well in private. That was not Alice. Her bond with her extraordinary husband, Bob, and her wonderful children and grandchildren was strong and wonderful to behold. And for those of us lucky to become part of her broader family, the warmth extended beyond shared political commitments. When I was pregnant and about to give birth in 2003, she proudly appeared at my door: she had the Wolf family bassinet in her hands. Your son, the child of two Moms, will be the first non-Wolf family child to sleep in this bassinet, she told me with delight.

I had sort of assumed Alice Wolf would live forever. Although we cannot escape the passage of time, with Alice, her energy, her drive to make a difference and her engagement in the world had never waned. At the news of her passing, I looked through emails and pictures; I quietly remembered. And I came upon her RSVP to the wedding celebration my spouse and I had twenty-five years into our union. She wrote this: Alice Wolf on Wheels for the Ellens! I could not believe it. Nearly thirty years after she and I had met, she remembered that event. But that was Alice. A woman with her eyes set on a better future who nonetheless remembered the importance of every moment. May we be enriched by her example — and may our wheels keep turning toward the justice she envisioned.

voted on whether to rehear the case, and none of the parties to the lawsuit requested a rehearing.

The court has become more conservative in recent years, with five of its 13 judges—excluding several senior judges—having been appointed by former President Donald Trump.

Christiana Kiefer, a lawyer with the conservative Alliance Defending Freedom, which represented the four Connecticut transgender athletes, said the group was pleased by the court's decision.

"Every woman deserves the respect and dignity that comes with having an equal opportunity to excel and win in athletics, and ADF remains committed to protecting the future of women's sports," Kiefer said in a statement.

Transgender athletes' ability to compete in sports is the subject of a continuing national debate. Eighteen states have passed laws banning transgender women or girls in sports based on the premise it gives them an unfair competitive advantage.

The four transgender runners filed a lawsuit in 2020 against the Connecticut Interscholastic Athletic Conference, the state's high school sports governing body, as well as several local school districts.

They sought injunctions to bar enforcement of

the state policy on transgender athletes and to remove records set by transgender athletes from the books between 2017 and 2020. They also sought money damages. All the student athletes involved in the lawsuit have since graduated.

In December, a three-judge panel said the four transgender athletes lacked standing to sue—in part because their claims that they were deprived of wins, state titles and athletic scholarship opportunities were speculative.

CIAC officials declined to comment Tuesday. The organization has said its policy is designed to comply with a state law that requires all high school students be treated according to their gender identity. It also said the policy is in accordance with Title IX, the federal law that allows girls equal educational opportunities, including in athletics.

Two transgender sprinters at the center of the lawsuit—Terry Miller and Andraya Yearwood, from Bloomfield and Cromwell, respectively—frequently outperformed their transgender competitors.

They were defended in the lawsuit by the American Civil Liberties Union, which said Tuesday that it looked forward to defending the state's policy again.

"As the initial ruling found, transgender girls lose nothing from the participation of transgender girls and Connecticut's policy simply recognizes the right of all student athletes to equal participation and protection under Title IX," Joshua Block, an attorney for the ACLU, said in a statement.

Christi Michaud said school officials also received emails and phone calls opposing the ban, which led to Wednesday night's vote.

"The board has listened to folks," Michaud told WMUR-TV.

Republicans across the country have been pushing anti-transgender legislation. While New Hampshire bans discrimination based on gender identity in housing, employment and public accommodations, state lawmakers are considering legislation that says public entities are capable of "differentiating between the male and female sexes in athletic competitions, criminal incarceration, or places of intimate privacy."

dents and their supporters.

The ban on urinals approved by the board was offered as a compromise measure to the proposal. It also capped the maximum occupancy for bathrooms and locker rooms at the number of stalls each contains, and prohibited students from using shared changing areas.

Dozens of students walked out several days later.

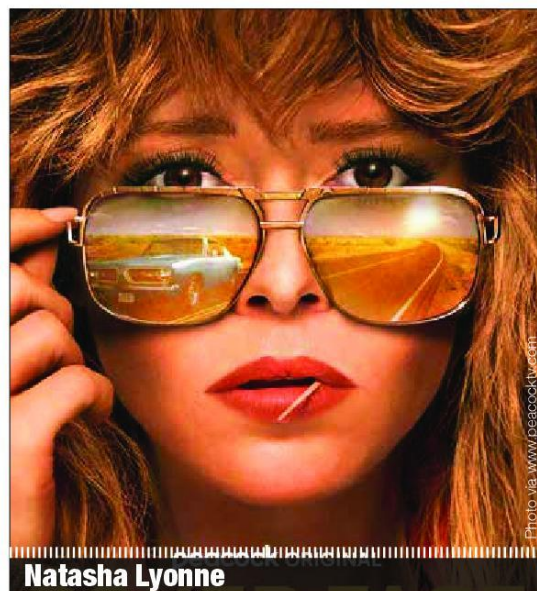

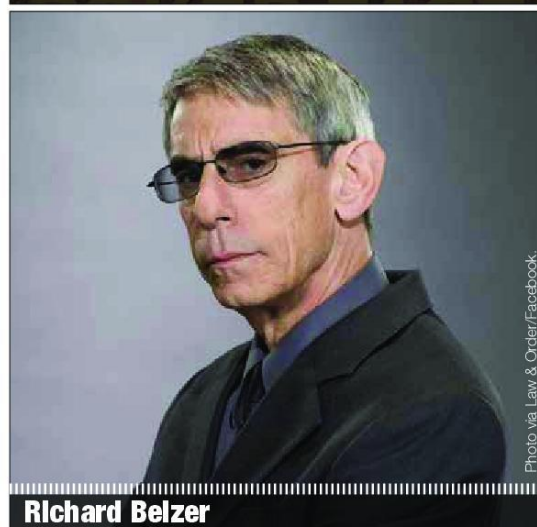
